

Shoestring Adventures USA Promotion Official Rules  
Shoestring Adventures Wilderness 1st Giveaway 2017

1. No Purchase Necessary; Entry Instructions. No purchase or payment of any money is necessary to enter. A purchase will not improve the chances of winning. To enter the promotion, user must enter their email address on <http://bit.ly/wilderness1st2017> between 12:01 am PST 9/22/2017 and 11:59 pm PST 10/6/2017. One entry per individual. Multiple participants are not permitted to share the same email address. Any attempt by any participant to obtain more than the stated number of entries by using multiple/different email or addresses, accounts, identities, registrations and logins, or any other methods will void that participant's entries and that participant may be disqualified. Use of any automated system to participate is prohibited and will result in disqualification.
